- All fees are due at the time of registration by way of post dated cheques.

For those in Keiki / Kaikamahine / Kane classes (Mondays)

Fall session 8 weeks + Winter/Spring session 20 weeks = 28 weeks total

7 postdated cheques as follows:

Oct 1st , Nov 1st 2011 / Jan 1st, Feb 1st, March 1st, April 1st, May 1st 2012

For those in Wahine & Makua Wahine classes (Wednesdays)

Fall session 10 weeks + Winter/Spring session 20 weeks = 30 weeks total

*note: wahine Tahitian class on Mondays is a bonus class which you may attend in addition to your Wed class

7 postdated cheques as follows:

Oct 1st , Nov 1st 2011 / Jan 1st, Feb 1st, March 1st, April 1st, May 1st 2012

PLUS 1 postdated cheque as follows:

Dec 1st 2011 (for ½ month fees since fall session is 10 weeks for Wed classes only)

- NSF cheques will be subject to a \$20 service fee
- Fees do not include costumes or implements. Expect to pay between \$30 - \$150 per costume.
- Fundraising encouraged but not required to help cover some expenses relating to costumes and workshops.
- In the event of permanent withdrawal from class cheques will be returned with the exception of the month in progress.
- Class sizes are limited and registration is on first come first served basis.

Keiki (up to age 8)	\$35* / 4 (¾-1 hour) lessons
Kaikamahine (ages 9-14)	\$35* / 4 (¾-1 hour) lessons
Kane (up to age 14)	\$35* / 4 (¾-1 hour) lessons
Wahine / Kane (ages 15+)	\$45* / 4 (1 - 2 hour) lessons
Makua Wahine (ages 30+)	\$45* / 4 (1 - 2 hour) lessons
Private (1-2 dancers)	\$50** / 4 (½ hour) lessons

*Group lesson fees are ½ price for additional immediate family members living in the same household when one full fee is paid.

*HST is in addition to the lesson fees listed above

**Private lessons are discounted 20% only when taking group lessons during the same period. Ask for more info on scheduling these lessons.
